## Hairy Pot Plants - Plants for People Update



For 4 weeks in April we ran our big plant giveaway scheme (Plants for People) in many local communities. With the help of a lot of fantastic volunteers, we delivered 87,575 plants to about 14,500 local households, that is over £480,000 of plants (retail value). We were overwhelmed by the generous responses and the tales of happiness prompted by the plants delivered.

Over a very short time we were able to efficiently clear all the crops that would otherwise have been composted by the time our garden centre customers reopened. Using the income generated by the plant giveaway, we speculatively potted fresh crops to be ready for sale later in the summer. Luckily when the garden centres did reopen demand was really strong and we have had records sales every week since. Sadly many of our visitor centre customers (National Trust, English Heritage etc) have not reopened their retail plant areas yet, so we have missed their usual summer custom, but the garden centres have thankfully compensated for their loss, with lots of new gardeners in the mood to buy plants.

The future of the nursery is looking more secure again after a chaotic

season and we count ourselves very lucky that we were able to find a way through some pretty tough times. We are very aware of many others who are still having to battle on.

We would like say a big THANK YOU all the hundreds of volunteers in those early weeks, who safely delivered the plants around their local communities, as well as our hero volunteer drivers and nursery helpers who put in so much work to support our hardworking but thinly stretched nursery team. We could not have done it without you all.

A highlight was definitely welcoming David Jones from Manna from Devon to Season Cookery School for a series of outdoor wood-fired cooking classes. The collection of events was such a success that we will be welcoming the team back to Season in the Spring for more outdoor culinary adventures.

As we move into the cooler months, the trees are turning, and the grounds are looking beautiful. Guests are outdoors exploring the estate or cosying up beside the open fires. The hotel is providing a true escape from the 'every-day' of the last few months.

The festive season always bring so much joy to Lainston House with the twinkling lights, mulled wine and indulgent food, but it is difficult to know how we will be celebrating this year but we are paving the way for as normal a Christmas celebration as possible and everyone from Lainston House would love for you and your loved ones to join us, should you be able to.

## Ham Green – Ash Die Back

An inspection of the Ham Green Ash trees was commissioned in May 2020, with the focus mainly on public safety along the footpath and bridleway running through Ham Green. All other types of large trees were also visually checked during the inspection.

### Two year programme of works

The survey report was published at the end of June and the results show that there is a significant amount of Ash Dieback in the HG trees. A total of 34 trees require felling and a further 12 require removal of dead branches, all over the next 2 years. Based on degree of damage to the trees and the likely risk to users of HG, the work has been split into 3 phases: Phase 1 within 3 months, Phase 2 within 6 months and, the remainder spread over the full 2 year period. A degree of monitoring of suspect trees will also be required during this period.

It has taken a while to establish the funding for this work and, to consider the logistics of dealing with such a large amount of felled wood in such a small woodland as Ham Green. The trees must be felled carefully in order to minimise damage to the surrounding habitat and, it is clear that the whole look of Ham Green will change considerably as the work progresses. When the work has been completed in each area, we will need to carry out a replanting programme to "fill in the gaps" for the future, using a selection of appropriate trees, some of which will be donated by people in the village.

### Top priority work from 2nd to 7th November

More immediately, Peter Yeates is scheduled to carry out the first phase of the work next week, from 2nd to 7th November. Most of this work will be along the upper (Western) section of the footpath, which runs down from Woodman Lane to the first green space near the footbridge to Stockers Down. This section of the footpath will be closed for the duration of the work and, advance warning signs have been posted. The bridleway just to the South of Ham Green Cottage can be used as an alternative path during the closure. The large Ash tree at the North end of the HG car park will also be felled during this first phase of work but, a date for this work has not yet been fixed.

Peter Yeates has agreed to take the felled wood as part payment for his work, so please do not go along afterwards and help yourselves! If you would like some of the wood, then please contact Peter (07789 644322) to discuss your requirements.

### Watch out for warning signs in Ham Green

Finally, if you are walking through Ham Green at all, please remain alert, look out for any warning signs and, stay well clear of any work sites for your personal safety. Thank you.

## Affordable Housing

### New Houses in Bostock Close



Winchester City Council are now working on the detailed documentation required to submit a planning application for the proposed housing.

There will be an opportunity to comment on the detailed designs at a further consultation before a planning application is submitted.

### Revised Car Parking Scheme

The biggest concern arising from consultations on the proposals to build the affordable homes in Bostock Close was the impact on parking facilities.

New Parking proposals were drawn up and a consultation process was started.

Following consultation with local residents, Winchester City Council have now drawn up a modified scheme to take account of the feedback received. Details of the revised scheme are now available and a new consultation period has commenced to take any final feedback from residents.




## Government Data on Lab Confirmed Positive Tests


## Covid Symptom Study App

**Flu vaccination campaign**

Hampshire County Council launched a flu campaign at the end of September for both staff and Hampshire residents. There have been wide ranging internal communications urging high risk groups and eligible staff to book their free flu vaccination as soon as possible.

For Hampshire residents, a weekly schedule of social media messages is being deployed throughout the season on Corporate and Public Health channels These are aligned with NHS communications and target specific groups week by week, including pregnant women, parents of 2 to 3 year olds, carers, people aged over 65 years and people with long term health conditions.

**Flu vaccination is important**

If you're at higher risk from coronavirus, you're also more at risk of problems from flu.

If you get flu and coronavirus at the same time, research shows you're more likely to be seriously ill.

It'll help to reduce pressure on the NHS and social care staff who may be dealing with coronavirus.

If you've had COVID-19, it's safe to have the flu vaccine. It'll be effective at helping to prevent flu.

## Road Safety

### If you see an incident

Please remember if you do witness a road safety incident for example vehicles driving at speed, HGVs that have no legitimate business in the village, causing obstruction and/or damage, vehicles driving too close to pedestrians, etc please report this to the Parish Clerk (clerk@sparsholtparish.org).

Any information such as, date and time, vehicle registration, company names on vehicles, photographs, etc will be helpful.

### Speed Limit Reminder Sign

The Parish Council is investigating community lead initiatives supported by Hampshire County Council. As part of this work, we are progressing the introduction of Speed Limit Reminder Signs

The necessary license has been granted and Hampshire Highways have ordered the required pole work/adjustments to be carried out on two of the proposed sites. We are waiting for a schedule to be produced which will involve the SLR sign moving between sites in Hursley and Sparsholt. Moving the sign is more effective than leaving in the same place and we share the costs with Hursley.

## Scams and Fraud

### HMRC Bogus phone calls

Some people in the village have received bogus mobile phone calls from HMRC and these could be considered to be very threatening – “We will be sending the police round to your door if you do not press 1”. **They are scams.**

HMRC is aware of an automated phone call scam which will tell you HMRC is filing a lawsuit against you, and to press one to speak to a caseworker to make a payment. We can confirm this is a scam and you should end the call immediately.

This scam has been widely reported and often targets elderly and vulnerable people.

Other scam calls may offer a tax refund and request you to provide your bank or credit card information. If you cannot verify the identity of the caller, we recommend that you do not speak to them.

### Local Fraud Scam - Good News

Back in September it was reported that one of our long-established residents had been the subject of a fraudulent scam, resulting in the loss of a significant sum of money. The fraud involved transferring money from a high street bank account to a supposed BNP Paribas ethical investment account.

The latest, really good news is that the lost sum of money has now been returned to the resident in full!

After much debate, the high street bank accepted that their account cross-checking processes were somewhat lacking at the time of the scam transfer, and were not in line with the new, more stringent checks which have been adopted by most other banks.

Consequently, they accepted liability and reimbursed the resident in full for the amount taken by the scammers. So, a very happy ending for our resident, after what must have been a very stressful and worrying period.
